 - Original letter from the student requiring a refund
 - Original Letter of Acceptance and Official Receipt from Bond Academy.

- Boarding fees must be paid in full at least one month before moving in.
- Boarding fees cannot be deferred.

STUDENT ACCOMMODATION AT BOND ACADEMY

Home-stay

A Home-stay Coordinator is available to students who need assistance in finding a Canadian family for their home-stay.

Home-stay features vary according to each home:

- private room, shared room
- meals
- access to telephone for local calls
- English speaking family.

Private Arrangement

Some families have friends or relatives in Toronto and can arrange for students to stay with them.
